33 Inspection:

34 Force Majeure

- . Failure or delay in the part of tenderer for supply due to force majeure causes enumerated here under shall be considered, provided the supplier produces documentary evidence.
 - a. Any cause which is beyond the reasonable control of the tenderer.
 - b. Natural phenomena, such as floods, drought, earthquakes, and epidemics.

On Supply:

50% cost of machinery / equipment shall be paid on receipt of machinery at Factory site location of the SPV (**PRECISION ENGINEERING AND TECHNOLOGY CENTRE, PP3, SIDCO Industrial Estate, Thirumudivakkam, Chennai-600132, Tamil Nadu**, INDIA).)

On Final Acceptance:

Balance 25% of the cost shall be paid after satisfactory installation, commissioning and performance of the machinery /equipment at the factory location of the SPV and after certification by our technical expert and after submitting the Performance Bank Guarantee for 10% amount of total value of equipment, valid upto 6 months after installation, commissioning of the machinery concerned.
